- 1) I have read, understand and agree to abide by the all rules of Carolina Sands Owners Association as posted on the community website (CarolinaSands.org)

- 3) I understand that I am responsible for cleaning the facilities used by my guests and that failure to do so will result in a \$75 cleaning fee.

- 5) Events may not create an unreasonable annoyance, inconvenience, or nuisance to other Members and their guests using the facility, or unreasonably interfere with surrounding residents' quiet enjoyment of their property. The parking lot may not be used as part of the event other than for guest parking.
- 6) I understand that facilities owned by Carolina Sands Owners Association, can not be reserved for exclusive use and must be made available for other owners and guests during my event. Exclusive use of the Clubhouse for events outside of pool season (usually Oct – May) are allowed.
- 7) on behalf of myself, my family and guests, to save and indemnify and hold the Carolina Sands Owners Association, its Agents and Assigns harmless from all losses, liability, damages and expenses, including attorney fees and court costs resulting from any injury or damage in anyway associated with the use of the facility. I accept the liability for damage to any property or injury caused to persons while attending the event. If alcohol is consumed, all State and Federal Regulations will be observed.
- 8) If using outside equipment (e.g. bounce house, slides, etc.) I am required to provide special event coverage and provide original insurance certificate for a \$1,000,000 general liability policy for a one-time event, listing Carolina Sands Owners Association as "Additional Insured" for the date of the event is required and must be submitted at least 48 hours prior to the event. For details please contact your home owner's insurance agent.
- 9) That Carolina Sands Owners Association may deny or revoke my event application without cause.
